GEG – development of the Klinikum Bremen-Mitte GmbH & Co. KG site

GEG is developing the new Hulsberg neighbourhood in a central location in

Bremen. It is selling the former plots of the Bremen-Mitte Clinic to third parties

so that they can construct building projects. GEG has already sold over 40 per cent of the gross floor area that can be realised for the exciting mix of residential and commercial uses. Next steps in the neighbourhood development: In autumn 2024, GEG will start building roads, squares and technical infrastructure, in summer 2025 the primary school in the new Hulsberg district will start operating, while GEG will continue to sell further plots in parallel. Currently on offer is the historic skin clinic together with a plot on which the "FRIEDRICH" mobility centre is being built. In addition, an elaborately coordinated sales process is being initiated for several plots of land that are being addressed exclusively to private building cooperatives. The new district with around 1,000 residential units, commercial facilities, a school, daycare centres and a training academy for nursing professions will be completed over the next five years.
